Pursuant to SEBI Master Circular No. CIR/ISD/AML/3/2010 date December 31, 2010 on Anti Money Laundering Standards and Guidelines on identification of Beneficial Ownership issued by SEBI vide its Circular No. CIR/MIRSD/2/2013 dated January 24, 2013.
